**ORDINANCE 2012-01  
PICK CITY, NORTH DAKOTA  
ORDINANCE AMENDMENT**

BE IT ORDAINED, by the City Council of the City of Pick City, North Dakota, that Section 3.5 and 4.9 of the Zoning Ordinances of the City of Pick City of 1978 are hereby amended to read as follows:

**3.5 Nonconforming Uses**

2. No building, structure, or premises where a nonconforming use has been discontinued for 12 months or has changed to a permitted use shall again be devoted to a nonconforming use.

**4.9 Recreational Vehicles**

4. RESIDENTIAL LOTS There are residential lots within the city limits of the City of Pick City which, under prior zoning law, were established to allow for recreational vehicle parking. After the effective date of this ordinance amendment, any of these lots where this use continues shall be treated as nonconforming uses under section 3.5 of the Zoning Ordinance. Until the use for recreational vehicles is terminated as provided in section 3.5, each such lot must be at least 25' wide, have water and sewer hookups, and contain no more the one recreational vehicle. One additional recreational vehicle per lot may be parked temporarily to accommodate visitors, but only for three days at a time and only three times during the year.
