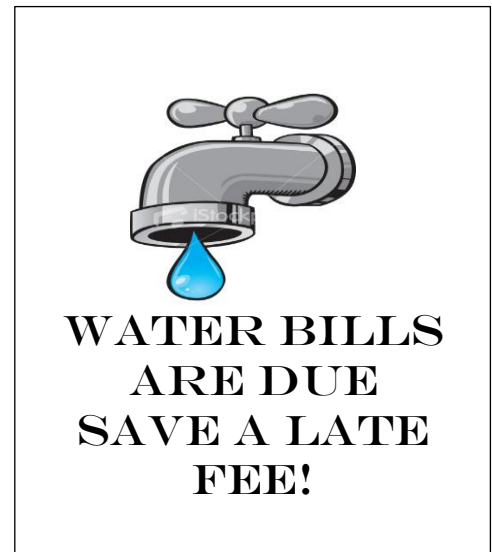

ORDINANCE 2007-01

PICK CITY, NORTH DAKOTA  
ORDINANCE AMENDMENT

BE IT ORDAINED, by the City Council of the City of Pick City, North Dakota, that Article V, Section 5.4 Building Permit of the Zoning Ordinances of the City of Pick City of 1978 is hereby amended to read as follows:

5.4 **Building Permit**

4. All building permits must be obtained before construction, and shall be required of all new building construction and external additions, regardless of the total cost of such construction.
5. The fee for the erection or addition of any structure within the zoning jurisdictional limits of the City shall be ten dollars (\$10.00) if the total of all construction costs is \$1,500 or less. Should the total construction costs be over \$1,500 then the building permit fee shall be \$25.00.
