City of Pick City Meeting minutes February 5, 2025 (unapproved minutes)

Present: Mayor, A. Anderson, Council; L. Davis, B. Reiser, S. Bather. Absent: Westman

Also Present: Auditor D. Johnson & PWD, J. Sailer.

Mayor called the meeting to order at 7:30pm.

Davis motioned, second Reiser to approve consent items.

Davis motioned, second Reiser to approve the Second and Final reading of ordinance "Residential Property with Water Shut Off" Roll call vote: all council present aye, Westman absent. Motion carried.

Davis motioned, second Bather to approve the Second & Final Reading of the amendments to Chapter 15 Building Code ordinance. Roll Call: all council present aye, Westman absent. Motion carried.

Fireworks ordinance was tabled to March Meeting.

Reiser motioned, second Davis to approve the ice fishing raffle #1-2025 for PCFD. All in favor.

Reiser motioned, second Davis to approve the 2024 Financial Statement prepared by Accountant. Auditor will publish in newspaper.

The fire department is considering purchasing a 75" flat screen for City Hall, and was asking the City to pay ½, it will be used for training and would benefit functions when hall is rented by others. The council agreed to ½ cost. The hall rental agreement will need to be changed to include the TV.

Auditor informed council on Western Plains Public Health process for nuisance properties. Council agreed to proceed with the nuisance property complaint and the actions will be conducted by Western Plains.

Motion by Davis, second Bather to cash in the \$1000.00 CD in Garbage fund and deposit into General Fund. All in favor.

City office will to closed 2/17/25 in honor of Presidents Day.

Landfill: burn permit send to NDDEQ, no response yet.

Park: Celebration (2026) would like to start committee if anyone is interested, please contact hall.

Water: Received letter from Moore Engineering regarding ND Dept. of Environmental Quality directing the City to perform additional work for the lead & copper water service lines.

MSWRD increased water per gallon, as per contract. Council agreed no increase is needed at this time to the City's customer rate.

Auditor informed the council that NDDEQ is requesting Jim & Diane's Social Security numbers for Opcert. (Operator's certification) Both Jim & Diane do not feel NDDEQ needs our personal information. Council agreed.
