Donny Wald approached the council about annexing property by Les Bornemann's, he would like to put three lots in the area. A new sewer line would need to be installed. Bids will be reviewed for installing the Main sewer line at the next meeting before any decision is made.

Reiser motioned, second Bather to approve the building permit for Arvid Anderson. Motion carried, Anderson abstained.

Bather motioned, second Reiser, to have Jim send back the damages electronic speed sign back to Elan company to see if it can be repaired. All in favor.


Auditor received one bid for painting the outside of City Hall, she will get more bids, and council will review at budget meeting.
